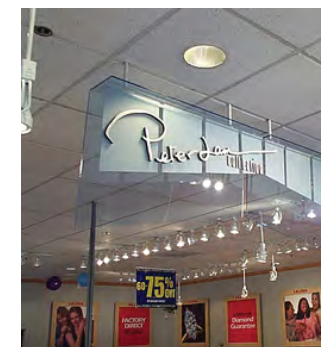

- Service Truck with 1 technician \$110.00 per hour / 1 hour minimum
- Service Truck with 2 technicians \$180.00 per hour / 1 hour minimum
- Crane Service available on request (pricing is job dependent)
- Licensed electrician \$175.00 per hour
- Off-Hours service and installation (weekends, weekdays after 5:30 pm) 1.6 times normal rate
- Emergency and holiday service rates are double normal rates (4 hour minimum)

Permit Aquisition Rates

- Staff time for permits \$60.00 per hour
- Staff time for meeting attendance \$90.00 per hour (includes travel to and from meeting)
- Design and Layout for signage permit applications \$90.00 per hour

Our service crews and vehicles are fully covered by New York State Disability Insurance, New York State Workers Compensation Insurance and Commercial Liability Insurance in accordance with New York State Law. Insurance certificates are available upon request. All installers are OSHA 10 hour course certified.

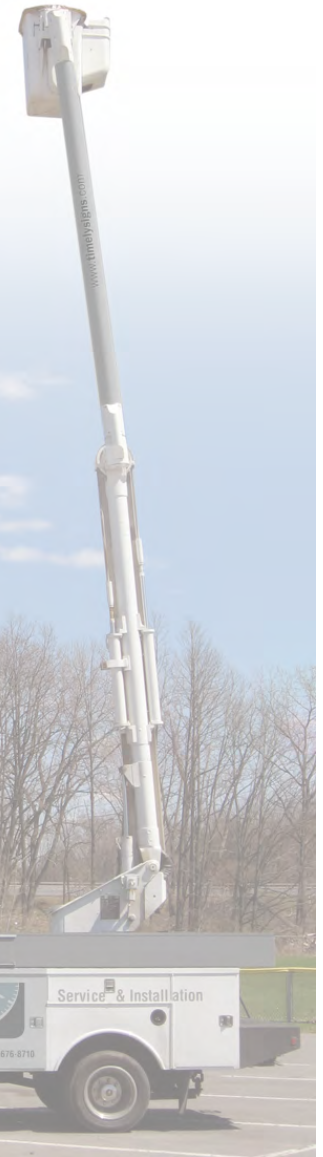

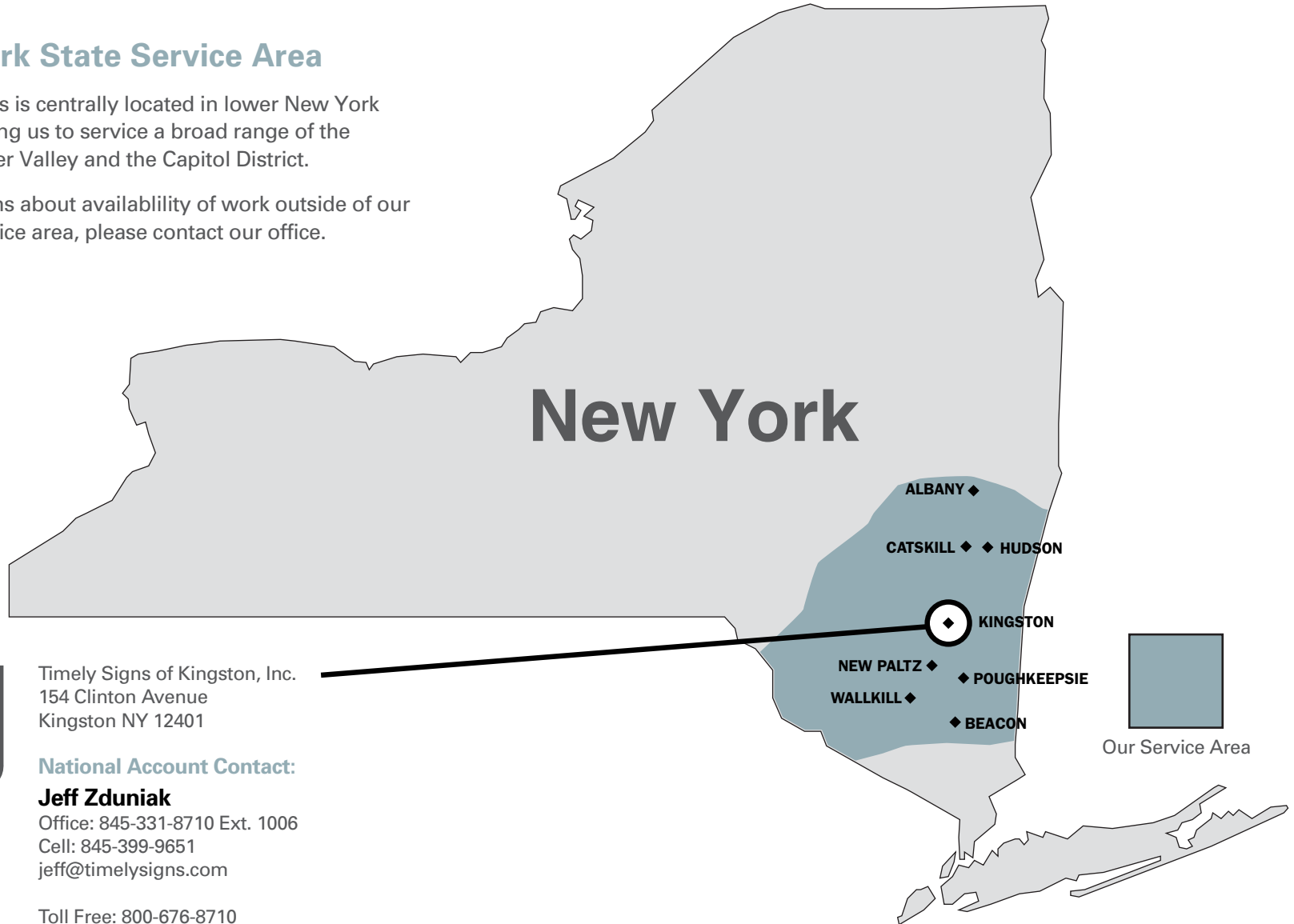
